Pupil Premium

The Pupil Premium Grant is additional funding given to schools to provide extra support to groups of pupils, to help schools close the attainment gap between children from low-income and other disadvantaged families and their peers.

Who is eligible for extra funding?

- Pupils in Reception to Year 6 who have been eligible for free school meals in the last six years
- Looked After Children (LAC), as one who is in the care of, or provided with accommodation by an English local authority
- Children who have ceased to be looked after by a local authority in England and Wales because of adoption, a special guardianship order, a child arrangements order or a residence order
- Pupils in year groups Reception to Year 11 recorded as Ever 6 service child or in receipt of a child pension from the Ministry of Defence

Our Aims for using the Pupil Premium Grant

- To narrow the attainment gap between children who receive pupil premium funding and those who do not
- To enable those children receiving the pupil premium funding to make expected progress by the end of KS1
- To enable those children receiving the pupil premium funding to make at least expected progress between KS1 and KS2
- To provide all children receiving the pupil premium funding to have equal opportunity to participate in educational and residential visits, having a positive impact on their well-being

A large part of our Pupil Premium Grant is used to provide extra Teaching Assistant hours. This allows us to provide:

- Small group work or 1:1 support within the classroom
- Intervention programmes to raise attainment in reading, writing and maths

The Pupil Premium Grant is spent on a range of initiatives and activities to make sure the above aims are met. These include:

- 1:1 and small group work to support individual / group learning in English and Maths
- Sessions with specialist TA to support emotional learning
- Covering the cost of curriculum and residential visits
- Assisting in covering the cost of music tuition for pupil premium children to remove financial barriers

How does the school use this money?

The school uses the Pupil Premium grant to run targeted corrections (some ongoing, some new) for pupils from vulnerable groups, and Governors ensure that the needs of socially disadvantaged pupils are adequately addressed. Children's progress is monitored through termly meetings between the school's senior management and class teachers, and governors receive reports on the results.

The Governors of the school recognise that not all pupils who receive free school meals will be socially disadvantaged. They also recognise that not all pupils who are socially disadvantaged are registered or qualify for free school meals. The Governors reserve the right to allocate the Pupil Premium funding to support any pupil or groups of pupils the school has legitimately identified as being socially disadvantaged. The Senior Leadership Team will maintain an ongoing programme of support for socially disadvantaged pupils, which will be overseen by the Governors' Curriculum Committee.

The school's Governing Body will continue to monitor teaching and learning throughout the school to make sure it meets the needs of all pupils, including those from deprived backgrounds.
